WAGE RATES

As of June 6, the 2021 wage rates are in effect! Journeypeople now earn \$36.14 per hour in gross wages, with a total package valued at \$61.51 per hour including benefits like health insurance, pension and more. - How much are monthly dues now?
 a. As of January 1, 2021, monthly union dues are now \$29
- 2. Why are my monthly dues not coming out automatically anymore?
 - a. If you work out-of-area (even near Milwaukee) or are laid off, we cannot use your vacation fund to pay monthly dues; in these situations, you need to make your payments manually
- 3. Does the union offer assistance for someone who is out of work due to COVID-19?
 - a. The union does not offer COVID-19 assistance at this time; some employers might still be offering assistance
- 4. Where can I find the working agreement, UBC constitution or other policy-related documents?
 - a. We have extras in the office; stop in at <u>5202 Monument Ln</u> in Madison to pick up a copy
- 5. Why haven't I received the dues card from my last payment?
 - a. If you're retired and would like a dues/work card, you must request one from Training at <u>608 241 0960</u> (if you don't already have a picture on file with us, you will need to come in to take one beforehand); dues payment receipts also function as work cards and can be requested from the local admin
- 6. Who do I talk to for general questions?
 - a. Always feel free to call the office at <u>608 240 0314</u>; we have a new full-time administrative assistant to answer your questions or at least ensure that you reach the right person to do so
